

Privacy Statement

This Privacy Statement ("Statement") applies to individuals who interact with [SubKeeper Family]("App" or "Service") as user. This Statement explains how your personal data are collected, used, and disclosed by [Wuhan Weican Technology Co., LTD]("we"). It also tells you how you can access and update your personal data and make certain choices about how your personal data are used. Please read it carefully. If you download the App, you expressly consent to this Statement.

Section 1. Personal data that we collect about you

We collect various types of information from you, as described below.

- the type, version, brand, language and operating system of device.
- device identifiers (such as IDFA, IDFA for Android, GAID for IOS).
- behavioral usage of the App.
- email address.
- the type and operator of network (such as Mac address).

Section 2. Purposes and use of data

The information we collected will be used for the following purposes:

- to monitor use of this App and to help its further development;
- to compile aggregate statistics about our users and to analyse App usage;
- to collect data for identity verification.
- to conduct researches and/or analyses from time to time.
- to operate internal control, resolve disputes, troubleshoot problems and enforce our terms of use.
- to deliver information to you that we believe you may have interest in, such as new services and other promotions and marketing materials.
- to contact you regarding administrative notices and communications relevant to your use of this App and to respond to your request.
- to comply with applicable laws and regulations as may be necessary.

Section 3. Disclosure of your data

Your data may be shared to non-third-party service providers for processing on our behalf. We may transfer or disclose the personal data we collect to third party contractors or subcontractors of us, as well as other third parties, which

may include providers of IT services, security and storage services, data analysis, data back-up and archiving, event management, and other services with respect to the operation of our service. We use such third parties to support us in providing our Services. When we transfer your personal data to third parties, we do so for the purposes described in this Statement and/or other internal or administrative purposes.

Section 4. Security of your data

We take steps to ensure that your information is treated securely and in accordance with this Statement. Unfortunately, no system is 100% secure, and we cannot ensure or warrant the security of any information you provide to us. To the fullest extent permitted by applicable law, we do not accept liability for unauthorized disclosure.

By using the Services or providing personal information to us, you agree that we may communicate with you electronically regarding security, privacy, and administrative issues relating to your use of the Services. If we learn of a security system's breach, we may attempt to notify you electronically by posting a notice on the App, by mail or by sending an email to you.

Section 5. Retention of your data

We will use your data for as long as necessary to satisfy the purposes for which personal data was collected above, unless it is necessary to extend the retention period or as required or permitted in accordance with applicable laws. That is, we will save your data for the entire life of the corresponding App you use as part of our services.

Section 6. Personal data of children

It is important to us to protect children's privacy. We do not intentionally collect personal data of persons under 13 years old. We encourage parents and guardians to regularly review and monitor their children's use of online activities. If a parent or guardian discovers that their child has provided us with personal data without their consent, please contact us immediately and we will delete such personal data immediately.
